Meeting Minutes:

1. Welcome and Adoption of the Agenda

Members were welcomed, attendance taken, and the agenda was adopted as presented.

2. Expenditure Plan 2018/19

A. Cocchia presented the 2018/19 Expenditure Plan and highlighted the following:

Operations: Revenue

- The carryforward amount is lower than in previous years due to the funds expended on the eHLbc website and logo refresh.
- The miscellaneous revenue includes funds received from legacy BC ELN, non-eHLbc partner libraries that continue to license PsycARTICLES after it became an eHLbc subscription.

Operations: Expenditures

While Management Committee meetings are usually held by teleconference, some funds
were set aside to hold an in-person Management Committee meeting in the Fall to discuss
strategic action planning and prioritising.

Licensing Initiatives

- eHLbc ended the 2017/18 fiscal year at a net loss as a result of not receiving a significant
 payment before the end of fiscal (the payment was subsequently received). The consortium
 therefore began the 2018/19 fiscal year with a deficit, but the payment is reflected in
 Member Cost Contributions category.
- The Administrative Centre anticipates ending the 2018/19 fiscal year with a carryforward of over \$100,000. The carryforward is made up of affiliate member licensing fees revenue and is used for future full member core suite subsidies.

3. Core Suite Renewal Update

L. Palmer reported that the Core Suite successfully renewed on April 1, 2018 and all 50 members renewed their commitment to the consortium. The current Core Suite has a four-year license term.

The Core Suite consists of nine EBSCO and Ovid health resources, including the newly acquired eBook Nursing Collection (includes approximately 550 full-text ebooks). More details about the Core Suite are available at: https://bit.ly/2NrfqeK

The Administrative Centre is investigating the most efficient way to retrieve MARC records for the eBook Nursing Collection. Currently, member institutions can retrieve MARC records through OCLC's WorldShare Collection Manager service.

4. Website Update

S. Nishimura announced the launch of the refreshed eHLbc website: https://ehlbc.ca/

The Steering Committee was reminded of the recommendation to upgrade the eHLbc Drupal Content Management System and website, approved in May 2017. The upgrade, completed in May 2018, improved the website's alignment with current security protocols, and allowed for future installation of modules facilitating creation of feedback tools, space for interest groups, and implementation of other 2017-2022 Strategic Plan actions.

Along with the website upgrade, the Administrative Centre refreshed the eHLbc logo and the website look and feel. The refreshed logo is available for member use at: https://ehlbc.ca/members/marketing

With the completion of the website upgrade, the Administrative Centre will turn its focus to other Strategic goals. Over the summer, an environmental scan of consortia similar to eHLbc is expected to generate ideas for:

- communicating the value of the consortium and building awareness of resources;
- mechanisms for knowledge exchange within membership; and
- tools and strategies for member training.

5. CPhA Update

Background

L. Palmer provided an update on the Management Committee's correspondence with the Canadian Pharmacists Association (CPhA):

- The Management Committee sent a letter, dated April 17, 2018, to CPhA expressing eHLbc's desire for continued partnership in providing member institutions with access to CPS and RxTx.
- In a response letter, dated April 23, 2018, CPhA inaccurately stated that eHLbc rejected the sales team's proposal to implement two distinct pricing models. In fact, eHLbc had communicated there was no issue with two different pricing models for the post-secondary and health sectors, yet had never received pricing from CPhA on which to begin negotiations.
- The Management Committee replied to CPhA on June 4, 2018, clarifying the inaccuracy and repeating its desire for a continued partnership with CPhA.

Discussion

The Steering Committee had a general discussion about individual member institutions' experiences negotiating pricing with CPhA. A number of eHLbc members reported cancelling their subscriptions to CPS or RxTx in response to price increases.

Steering Committee representatives discussed how the Management Committee might proceed with CPhA, including continuing discussions with the CPhA Board, a discussion space on the eHLbc website, and advocating for the BC Ministry of Health to pay for CPS and RxTx on behalf of the entire province.

6. Elections Update

A. Helmuth reminded the Steering Committee that D. Schachter and T. Mundle are finishing their terms on the Management Committee. Thanks was expressed to both of them for their years of service on the Committee.

Before this meeting a call-out was sent for nominations for two post-secondary representatives to fill those positions.

A. Helmuth reminded the Committee of eHLbc election protocols:

- Elections are staggered so that post-secondary and health representatives are elected in different election cycles.
- In the year that the incoming Chair of the committee is from the post-secondary sector, the post-secondary representatives stand for election. In the next year, the Chair is from the health sector, and health representatives stand for election.
- The Chair and Vice-Chair are always excluded from the election cycles.

Once nominations are closed, elections will be held by electronic ballot amongst the post-secondary representatives on the Steering Committee.

The terms of the new Management Committee representatives and the new Chair and Vice-Chair begin on July 1, 2018.

7. New Business

There was no new business.

8. Next Meeting

Draft minutes from the meeting will be sent to Steering Committee representatives for approval via email. The next Steering Committee teleconference will be scheduled for Fall 2018.
