Progress on Action items from October 29, 2007 minutes:

Management Action Items:

- 1. There will be a call for nominations for health authority co-chair and a new health authority Management Team member. May send nominations by December 1st to Nancy Levesque. If there are multiple nominations a vote will be held by the Steering Committee.
 - Election of new health sector co-chair-Greg Rowell to open up co-chair position, e-HLbc Steering Committee members present re-nominated Greg, by acclamation Greg will continue on as co-chair.
 - Ruth Rochlin is now the new health authority Management Team member.

Marketing/Communication Action Items:

- 1. Brochure will be re-edited to allow member libraries to add their own branding.
- Request that members send in success stories to be highlighted in general e-HLbc marketing strategies and documents. e-HLbc Admin Centre will investigate ways to collect stories on e-HLbc web site.
- 3. Request to investigate the feasibility of creating a members only blog
 - Marketing materials: updated e-HLbc brochure, produced new brochure, fact sheet and postcards. Soon to be up on website for members to customize.
 - Acquired over 15 success stories. Set up a "quotes" database for web site display. However we need more success stories. Request to Steering Committee to talk to users and send in more anecdotes.
 - Member blog request added to communication strategy plan. Item appears on the road map for May 2008 discussion.

Training Action Items:

- 1. e-HLbc Admin Centre will launch the Training Needs Assessment survey in the next couple weeks.
- 2. e-HLbc Admin Centre to ask Ovid folks to do more training sessions on the new platform in other areas of the province.

- New products process begun (e-Box). Reconfirm to membership that this
 is an opt in/opt out process for any new products beyond core suite.
 Recognize need to grow, economies of scale for separately licensed
 products by many members could potentially be incorporated.

There will be a follow-up e-mail with tasks and specific skills needed, send to info@ehlbc.ca; team will focus on new products not core suite renewal. Admin Centre and the Management Team will work with the team to map out strategy, clarify pressure points and tactics.
- BCLA conference: reception a great success, e-HLbc received a BCLA merit award for outstanding program. The e-HLbc panel session was well attended with 25 people. Comments from attendees about concerns for consortium sustainability.

 commitment to license on member's part. Management Team needs to
 know potentials. There is need for content but the end result seems likely
 to be a boutique [opt in/opt out] license arrangement.

- Developed strategy, timelines, floor display, new brochures, postcards, fact sheet
- Discussion of e-HLbc branding on member websites; no clarity on how we
 can evaluate e-HLbc e-resources when people don't know what they are
 using; branding helps with the continuum for students moving to
 professional practice branding partnership issue. Difficult to go out and
 get funding when no evidence is present, multiple branding doesn't take
 away, HKN University of Alberta includes several branding; helps carry
 forward recognition of resources from academic to health authority.

Highlights include

- Commitment to third year renewal worked with BCAHC to send invoicing
- Preliminary work for core suite renewal in process

- Agreement of Physiotherapy Association of BC and the Massage Therapist's Association of BC to renew affiliate membership for 2008-2009
- Sent affiliate membership inquiries to several associations: the BC Association of Optometrists, the BC Pharmacy Association, the British Columbia Dental Hygienists' Association, Dietitians of Canada, BC Region and the Midwives Association of BC
- Deployed e-Box on April 7th. Will run through end of May 2008. Fifteen suggestions to date
- Aggregated e-HLbc full-text adds, changes and deletions (http://ehlbc.ca/databases/content-updates/)
- Preliminary collection of success stories, anecdotal positive e-HLbc experiences. Established "Quotes" database for web site
- Extensive Evaluation Committee support work
- Handout e-HLbc "Year in Review", highlight use growth among members, slight decrease in searches. Suggest decrease due to increased skill level attained by users as a result of training efforts.
