# Assessing e-HL*bc*

As a part of the evaluation process, the Evaluation Subcommittee has developed an "e-HLbc Health Database User Survey" (http://bceln.ca/surveys/survey.php?sid=39). This survey gathers the varied ways that e-HLbc resources are making a difference in the delivery of healthcare, patient care outcomes as well as support academic or clinical research related needs from a practitioner, researcher or student point of view. The data and information gathered will help formulate some of the evaluative information for the e-HLbc program renewal.

The survey will run for about four weeks from April 1st to May 1st. There will be a nice incentive for users to fill out the survey. Once the survey is complete, users will have the opportunity to put in their contact information for a drawing to win an iPod nano. Their contact information will not be associated with their survey answers. The answers are completely anonymous.

The Committee asks all member institutions to publicize this survey to their users as best they can. Member efforts and support in this endeavour will help the Committee gather data and information on the impact of e-HLbc.

Ideas for promoting the survey:

- Sending the survey link to appropriate end user groups in your facility or campus.
- Adding a link to your library database page or e-resource description page.

It contains over 100 citations from 1970 to present documenting the research that has been done to substantiate that access to online health resources and a library do indeed make a difference in patient care outcomes. # e-HLbc Electronic Suggestion Box

e-HLbc members have been asking for a process to suggest new products for potential consortial licensing. On April 7th, 2008 the "e-HLbc Electronic Suggestion Box (e-Box)" was launched allowing for the membership to suggest potential new products of interest. Participation in this process does not obligate any member to license new content. New e-resources are in addition to the core suite of products and licensing will be optional.

The forum is accessible from the e-HLbc members' only website (http://notinmylibrary.com/ehlbc/index.cfm) and requires a login and password. Staff from member institutions may request a login by contacting the Administration Centre at info@ehlbc.ca.

#### Summary highlights

- Only full and affiliate members may participate.
- e-HL*bc* Electronic Suggestion Box (e-Box) will be composed of three basic parts
  - » Electronic suggestion box
  - » Electronic discussion forum
  - » Ranking survey tool
- Product suggestions will be made at a designated period of the year, and members may submit as many as they wish. Members will be reminded to submit suggestions. Inquiries from product vendors will be directed to membership.
- Trialing, evaluation and decision-making of potential e-resources will take advantage of the appropriate budgetary windows to allow maximum e-HLbc membership participation.
- New product(s) licensing will be rolled into the overall renewal timeframe for core suite eresources (April 1st to March 31st subscription cycle).
- New product(s) selections will be based on the ranking results along with overall health content needs on a provincial level.
- Member participation in licensing new products will be optional.

It is anticipated that the forum will be open from April 7th until May 31st. After this initial suggestion period the forum will be closed for the preparation of a ranking survey. The survey will be sent to designated representatives from the full and affiliate membership to indicate their level of interest for the products suggested (low, medium, high) in early June. Products will be ranked by membership in order of priority for acquisition.

The e-HLbc Management Committee will review the ranking survey results over the summer and identify the top three to five potential product recommendations for trialing and investigation in August. The Administrative Centre will contact the vendors of the top three to five choices for preliminary (retail) content pricing for the consortial membership.

By October 2008, a Negotiation Team will be appointed to arrange trials and commence with vendor discussions and licensing negotiation. Feedback from membership concerning trial results will be requested. Participation in the trial process does not obligate any institution to licensing new content.

The Negotiation Team will produce a product analysis report for the Management Committee that will consider a variety of inputs that may include membership resource trialing feedback, vendor negotiations, pricing models and balancing consortial collection requirements and needs. The Management Committee will make its final recommendations to the Steering Committee for what product(s) licensing will be pursued for e-HLbc. Decisions from membership on whether they plan to participate in licensing any new e-resource will be gathered in January and February for an April 1st, 2009 start date. Participation is not mandatory.

# Determining Affiliate Membership Requirements

The Membership Committee and the Administration Centre have been assessing the two pilot projects with the Physiotherapy Association of BC and the Massage Therapist's Association of BC to determine an appropriate content and administrative fee structure for new affiliate members. Ideally, affiliate membership is potentially open to any health professional association, post secondary institution or health organization in the province. Practitioners must be associated with members or affiliate members in order to have access to e-HLbc resources.

The fee structure will be based on two parts: a membership fee to cover the costs of administration/support and a licensed content fee. There will be a percentage increase per year in fee structure as negotiated through the licensing process with the vendors. For the 2006–2009 period, it is 4% a year. For the fiscal year 2008–2009 the content fee is \$6 per FTE or \$500, whichever is greater. Content fee structure will likely change when contracts are renegotiated in 2009 for 2009–2012 license period.

The administrative fee will be determined by what level of support is needed from the Administrative Centre. The application process will involve a meeting to formally analyze tier support placement.

#### **Affiliate Membership requirements**

- Embrace the vision, mission and strategies of e-HL*bc* and share the core values and principles of e-HL*bc*.
- Be part of a post-secondary institution or health sector organization or association operating in British Columbia.
- The Affiliate member must abide by the conditions and requirements of the various vendor licenses negotiated by e-HLbc. It must provide secure and authenticated access to resources, restricted to its bona fide members.
- Pay administrative and content license fees annually as approved by the e-HL*bc* Steering Committee.
- Provide full time equivalent (FTE) numbers annually.

It is highly desirable that Affiliate Members:

- Have adequate and dedicated library staffing levels.
- Have functional technical support so that users can access e-HLbc licensed databases.
- Have appropriate staffing support so that instructional/troubleshooting assistance to their organization's users is available for licensed databases.
  - *Tier 1 Minimal Support \$500* Prospective member can fulfill all technical support requirements.
  - *Tier 2 Medium Support \$1000* Prospective member requires some moderate support assistance.
  - Tier 3 Maximum Support \$1500
     Prospective member requires high level of support assistance.

Evidence Based Medicine Reviews from Ovid is an important source for online EBM information, with authoritative, definitive topic, article, and technology reviews, as well as access to information on controlled trials. You get single-click access to seven of medicine's most trusted EBM sources in a single, completely integrated, fully searchable resource.

Ovid has recently added three new files which are available to e-HL*bc* members :

- COCHRANE METHODOLOGY REGISTER (CMR)
   CMR is a bibliography of more than 9,000 references to controlled trials in journal articles, book chapters, conference proceedings and reports, and other publications of methodologies used in health studies.
- HEALTH TECHNOLOGY
   ASSESSMENTS (HTA)
   HTA brings together details on ongoing studies of the medical, social, ethical and economic implications of healthcare interventions.
- NHS ECONOMIC EVALUATION DATABASE (NHSEED) NHSEED provides cost-benefit analyses about healthcare interventions, with more than 6000 abstracts of quality assessed economic evaluations.
